**CANCELLATION NOTICE : GENERAL BODY MEETING
SCHEDULED TO BE HELD ON 16.10.2022(SUNDAY)**


Reference Society's Notice dated 17.09.2022 and dated 6.10.2022 regarding conduct of General Body Meeting for Amendment in Bye-Laws of NSG SAS LTD.

2. Due to violent interruption of Shri Praveen Kataria, Ex Asstt Secy of Interim Committee of Team of Administrators (Resident of A-46) on 14.10.2022, in which he along with four other locals namely Shri Sunil Kumar Nagi (B-50), Shri Vinod Kumar (A-30), Shri Devender Kumar (B-78) and Shri Rohit Kumar (C-59) entered into the Society Office at 1130 HRS and threatened to disturb the conduct of General Body Meeting (scheduled to be held on 16.10.2022) till such time they are not declared bonafide Members of the NSG Society. Shri Praveen Kataria threatened that he should not be quoted as Property Dealer in the various correspondences issued by Society during last few months, and also threatened the Secretary in presence of Shri N.K. Gupta, Treasurer and Shri Deepak Kumar, Manager (Admn), to issue a revised Voter List of Members including all the names which he had prepared in 2018 for conduct of Election. He declared that all the files and documents were handed over by him on 31.1.2020 to the President and no further papers or documents should be asked for re-construction of files.





After noticing tone and tenor of Shri Praveen Kataria and his friends on 14.10.2022 and earlier violent visit of Shri Praveen Kataria on 09.10.2022, it is felt that they may disrupt the conduct of General Body Meeting and may create unpleasant scene there, as such it would not be feasible to conduct smooth functioning of GBM. Therefore, the conduct of GBM dated 16.10.2022 as intimated vide our Notice dated 17.9.2022, is hereby cancelled till further orders to avoid any untoward happening. Our Notice dated 17.9.2022 and letter dated 6.10.2022 is also cancelled hereby.
