3. Members/Plot Holders are therefore, requested to submit following details in respect of their tenants without further delay:-

- a) Name & Photo of Tenant
- b) Copy of ID Proof of tenant (Aadhar Card/Pan Card/Voter Card)
- c) Total No. of family members of tenant (as per Rent Agreement)
- d) Home Address & contact no. of tenant
- e) Copy of Rent Agreement
- f) Copy of driving license and Vehicle Registration Certificate, if any.
- g) Copy of receipts on Welcome Charges (onetime payment of Rs.1000 only) paid to Society.
- h) Copy of Police Verification.

4. In spite of earlier requests, requisite information in respect of tenants has not been submitted. It is requested, that the information, as required, may please be submitted at the earliest failing which house nos. having tenants will be furnished to the concerned authorities including Police for verification and further necessary action. The process of submitting necessary documents may please be completed at the earliest latest by 05.12.2022.

5. In all future cases, prior giving their houses on rent, Members/Plot Holders must intimate the Society in advance to avoid inconvenience, if any.
