PROFORMA NOTICE

ADVICE TO MEMBERS/PLOT HOLDERS TO REMOVE ROADSIDE ENCROACHMENT FROM SOCIETY COMMON AREAS/SERVICE LANE.

Members/Plot Holders of NSG Sahkari Avas Samiti Ltd were advised vide Society Notice No.4 dated 20 July 2022, that roadside open area upto storm water drains and outside boundaries of individual plots have been kept as common area and Service Lane to facilitate provision of water pipelines, gas pipe lines, electrical cables, optical fibers, telephone cables and Sewer Line etc. Any encroachment in the common area of Service Lanes by erecting temporary/permanent structures, temporary or permanent construction of brick walls/iron or net fencing, putting grills, farming activities etc are highly objectionable since these are not only illegal but a serious security threat to Senior Citizen/Children, Pedestrian, Cyclists and morning/evening walkers putting their life at high risk.

- 2. Post COM meeting dated 14th August, 2022, Society issued Notice No.12 dated 25th August, 2022, in which deliberations of COM meeting on illegal encroachment were shared by pinpointing some of the individual plots with advice to remove illegal encroachment from roadside common area. It has been noticed that even after lapse of considerable time hardly any action for removal of encroachment has been taken.
- 3. It has been decided in the COM Meeting held on 11.09.2022 to give final notice to the concerned Plot Holders advising to remove unauthorized encroachment. In view of this, it is advised to remove unauthorized encroachment latest by 30.11.2022. In case unauthorized encroachment is not removed by stipulated date, GNIDA being land owing agency shall be approached to undertake programme for removal of unauthorized encroachment at the cost of concerned Member/Plot Holder. It may also be pointed out that GNIDA is the final authority for keeping common area of the Society free of encroachment. Photograph of encroachment is also enclosed.
