

- Sale/Purchase of plots and transfer of Membership cases in NSG SAS Ltd have been examined based on case files/documents/records available/held in the office while re-opening the locked Society's Office on 31.12.2021 and documents as provided by concerned owners/Members with regard to Transfer Memorandum of GNIDA and registration of Transfer Deed of their Plots in their names. The same has been examined by the Committee of Management in its meeting dated 13.11.2022 and approval accorded for circulation for information of all concerned. After detailed examination, Provisional List of Membership has been prepared by categorizing into the following categories:-

when I

<u>CATEGORY-I</u>: Wherein Society Model Bye Laws No.5 and Bye Laws No.107 have been followed in terms of UP Co-operative Society Acts and Rules and subsequent approval of UP Avas Evam Vikash Parishad, Lucknow were obtained under Bye Laws No.107. All such cases have been included in the subject list of Members and in all such cases purchasers of plots have become regular Members now.

CATEOGORY-II: -Wherein Society Model Bye Laws No.5 was followed but Bye Laws No.107 could be followed partially only. In that, Committee of Management had accorded approval on Sale/Purchase of Plots and the proposal were sent to UP Avas Evam Vikash Parishad, Lucknow also for approval of Membership under Bye Laws No.107 but the same remained incomplete due to some reasons or others. All such cases will be re-considered and COM proposals will be sent afresh to UP Avas Evam Vikash Parishad, Lucknow for reconsideration and accord of approval. We have already sent cases of five such transactions based on decision taken in last COM Meeting. Such cases have been included in the list provisionally.

CATEGORY-III:-Wherein, COM had examined cases of Sale/Purchase of Plots positively but did not seek required approval of UP Avas Evam Vikash Parishad, Lucknow. Most of the cases processed during Financial Year 2014-15, 2015-16 & 2016-17 have been found in this category wherein the then COM decided that such cases need not to be sent to UP Avas Evam Vikash Parishad, Lucknow and they got their stand approved by the AGM also, held for F/Y 2015 & 2016. That was unfortunate and may be considered lapses on their part since approval of UP Avas Evam Vikash Parishad, Lucknow under Society Bye Laws No.107 and Letter dated 13.7.2006 (copy with Notice 15 dated 3.9.22 on Website and WhatApp) is must. All such cases are required to be re-considered to follow the set procedure and this General Body (GBM) approval would be required since decision for not sending such cases to UP Avas Evam Vikash Parishad, Lucknow was taken in the AGMs held for FY 2015-16/2016-17. Cases of all such purchaser of plots need to be sent now once the GBM gives approval. Names of such plot holders have been included in the list provisionally.



CATEGORY-IV:- Wherein cases of Sale/Purchase of plots were not put up before the Committee of Management for approval and also not sent to UP Avas Evam Vikash Parishad, Lucknow under Bye Laws No.107 and Letter dated 13.7.2006 (copy with Notice-15 dated 3.9.22 on Website and WhatApp). Most of the cases of Sale/Purchase of plots held during F/Y 2011 and 2012 appears to be in this category. The then Secretary had issued NOC for Greater Noida Authority for TM directly. Since, Land Audit by UP Government Officials on each Sale/Purchase of plots of NSG SAS LTD will also be taken up based on High Court Orders (Notice No.19 dated 6.10.22 refer), we cannot consider to include such cases in the List of Members. This GBM has to decide for consideration of these cases by present COM for taking up matter with UP Avas Evam Vikash Parishad, Lucknow to request them to accord approval Ex-Post-Facto.

<u>CATEGORY-V</u>:- Wherein case file of Original Members is missing and no records held/available in the Society office on Sale/Purchase of plots by Members. In this regard, refer Para-4 of Society Notice-15 dated 3.9.2022. Such cases have not been included in the list of Members. Their cases can be considered only after availability of documents/records on the matter.
