**DOG MENACE IN NSG SOCIETY : RESIDENTS PROECTION ALERT.**

The present Management of NSG Society had approached CEO, Greater Noida Authority vide our letter dated 18.2.2022 (copy attached) for capturing the violent dogs of Society to rehabilitate them elsewhere and arrangement for sterilization of dogs to restrict increasing population of dogs in the Society. In response to that, Greater Noida Authority vides their letter dated 02.03.2022 (copy attached) had directed the NGO-Human welfare Society, Giriraj Nagar, ISCON Road, Mansarover Jaipur Rajasthan to arrange for dog's sterilization and vaccination. The Society had deposited necessary fee for sterilization and vaccination cost of aprox 30 dogs as per their demand. They had arranged capturing of dogs for the same and left the dogs back after vaccination and sterilization operation. However, they raised complaint during their second attempt that some house owners/residents had obstructed dog capturing process by hiding the dogs in their houses and as a result they failed to complete the required capturing of 30 dogs and also denied to take up their next attempt due to likely obstruction put by some dog lovers. The process could not be completed.

2. We are again facing the same problem. Dog bite cases and stray dog attacks are on rise and senior citizens and children's are at high risk being soft target. Recently, number of cases of dog bite has been reported and published in Newspapers also. Showing love for dogs is not bad but it should not be at the cost of serious risk to human life. Recently some residents had tried to put





that dangerous bitch with her puppies outside NSG Society Gate No.1 with due arrangement of safety of puppies and had arranged for their food also. But, some dog lovers (as has been reported that Mr. Srivastava of Plot No.A-09) brought them back and put these dogs in neighbor's Plot No.10 without any prior permission. Plot holder Shri Tanwar has raised a complaint also. Earlier the same bitch had bitten Col. K.C. Goswami (Retd) and two-three other residents. It is learnt that number of people has been injured by one female dog at corner near Gate No.1. Residents feel very vulnerable with large number of dogs and puppies. It is reported that even the road leading to A-41 two dogs always chase Scooters and Pedestrians. This has been happening time and again. People feel exposing children and elderly people to such ferocious attack can be traumatic as well as safety hazard. We have got complaints from Lt.Gen A.R. Prasad (Retd), Maj Gen T.S. Sidana (Retd), Shri Tarun Tiwari, Shri M.P. Singh and Shri P.K.S. Nair also against rising dog bite cases and stray dogs attack in "A" Block mainly because of that bitch. Complaints have been received from residents of "C" Block and "B" Block also. This is most unfortunate and undesirable that dog lovers do not care for others and put their life at high risk.

3. Management is retrying to convince NGO to restart process of capturing and sterilization of dogs to restrict dog population. The NGO Agency as authorized by GNIDA, has now expressed nod and ready to take up the process in IInd and IIIrd week of December, 2022. The residents are requested to cooperate and do not make our efforts futile by hiding such dogs at the time of operation of dog capturing. In case stray dogs which are being fed by residents regularly, they will be fined appropriately in case of dog bite considering the dog as Pet dog. While the NGO will re-start the process, the residents of NSG Society may consider seeing some alternatives e.g making some food points out side near Gate No.01 to feed the stray dogs. This way we may put some control over dog menace as the hungry dogs are more dangerous. **Those who are keeping pet dogs must get registration of their dogs and do all necessary formalities e.g. timely vaccination etc. and must accompany dogs while moving them out and keep cleanliness by using dog poop cleaner/scoopers and bags.** It may also be pointed out that Authority imposes penalty of Rs.10,000/- in case of pet dog bite.
